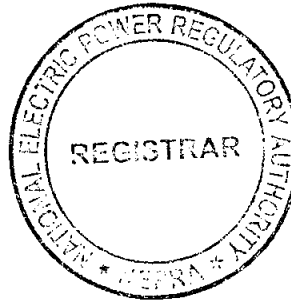



The Authority hereby grants Generation Licence to Mrs. Urusa Zubairi, for 10.0 KW photovoltaic solar based distributed generation facility, having consumer reference number LA068885, located at Plot NO 82/2 Comm, Street 22, Phase IV, DHA Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
