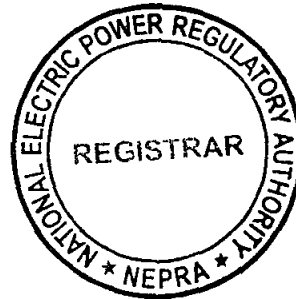



The Authority hereby grants Generation Licence to Mr. Amanullah Qureshi, for 12.840 KW photovoltaic solar based distributed generation facility, having consumer reference number LB322309, located at House No B-388, Block No.14, Gulistan-E-Johar Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
