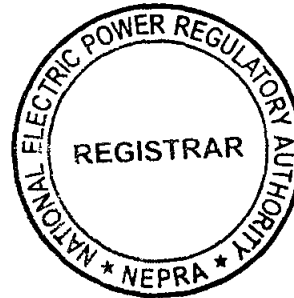

The Authority hereby grants Generation Licence to Mr. Anjum Sharif, for 15.680 KW photovoltaic solar based distributed generation facility, having consumer reference number AL353744, located at House No. 215/3, Sharifabad Karachi, under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. This Licence is valid up to 19th day of Oct, 2028.
