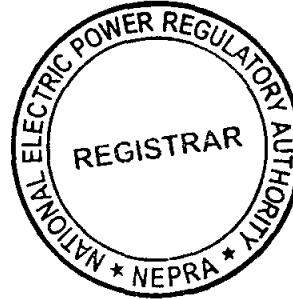



The Authority hereby grants Generation Licence to Mrs. Shaheen Begum, for 14.98 KW photovoltaic solar based distributed generation facility, having consumer reference number LA702879, located at P No. 94/2, Street 19, Khayaban-e-Rahat, Phase-VI, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
