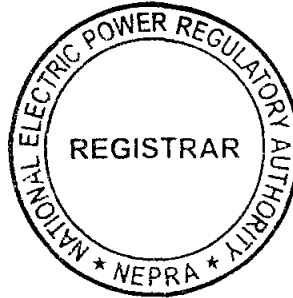



The Authority hereby grants Generation Licence to Mrs. Shah Jehan, for 10.35 KW photovoltaic solar based distributed generation facility, having consumer reference number LB127891, located at GRT No.H-1/09, H-Area Malir Colony, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 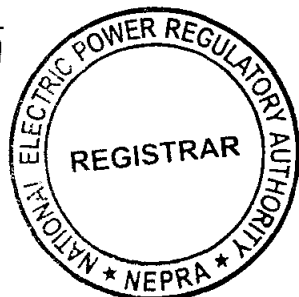
