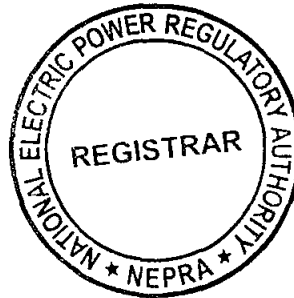



The Authority hereby grants Generation Licence to M/s. Niraav Foods, for 239.995 KW photovoltaic solar based distributed generation facility, having consumer reference number BH001527, located at Plot # A-66, Bin Qasim Eastern Industrial Zone PORT QASIM under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 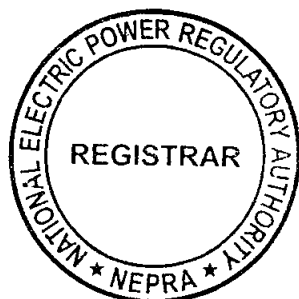
