

The Authority hereby grants Generation Licence to Mrs. Kausar for 25.380 KW photovoltaic solar based distributed generation facility, having consumer reference number LA775143, located at Plot # 54, Zulfiqar Street, PH-VIII, DHA Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
