

The Authority hereby grants Generation Licence to Mrs. Zarin Asim for 42.120 KW photovoltaic solar based distributed generation facility, having consumer reference number LB120274, located at Plot No 95/1, Khayaban-E-Muslim Ph-VI, DHA Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
