

The Authority hereby grants Generation Licence to Towellers Limited for 49.050 KW photovoltaic solar based distributed generation facility, having consumer reference number LA021942, located at Plot No-WSA 30, Block-1, FB Area Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
