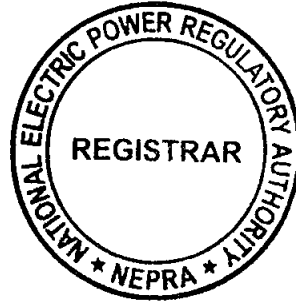



The Authority hereby grants Generation Licence to Quality Rice Mill for 199.775 KW photovoltaic solar based distributed generation facility, having consumer reference number BH001211, located at E-57/A, NW Industrial Zone Port Qasim under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
