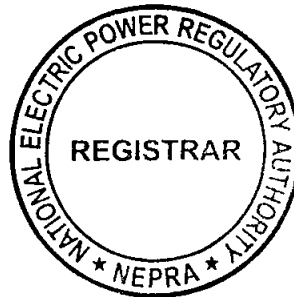



The Authority hereby grants Generation Licence to J Sons Industries Salman Jameel for 249.480 KW photovoltaic solar based distributed generation facility, having consumer reference number BL005194, located at Plot 50, SEC-27, Korangi Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
