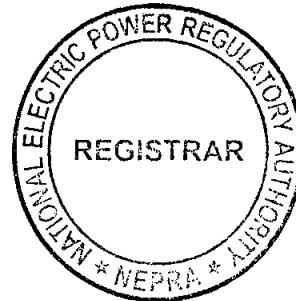

**GENERATION LICENCE**

The Authority hereby grants Generation Licence to Mr. Mohammad Fazil Bharucha for 34.880 KW photovoltaic solar based distributed generation facility, having consumer reference number AL462752, located at Plot F7/1, Block 8 Scheme 5 Clifton Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 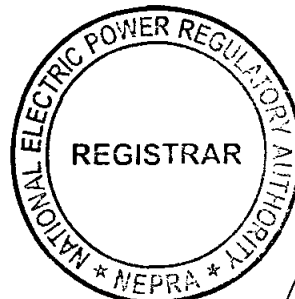
