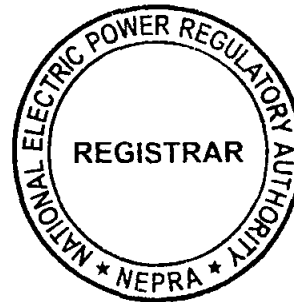



The Authority hereby grants Generation Licence to AA Enterprises for 84.11 KW photovoltaic solar based distributed generation facility, having consumer reference number BL006946, located at Plot No. 6-C and 6-C/1, Sector 12-D North, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
