

The Authority hereby grants Generation Licence to Jamia Anwar UI Uloom for 35.425 KW photovoltaic solar based distributed generation facility, having consumer reference number LB082575, located at Plot No. 3/2, Sector 6/E, Mehran Town, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
