

The Authority hereby grants Generation Licence to Ms. Amtul Haseen for 26.400 KW photovoltaic solar based distributed generation facility, having consumer reference number LB294658, located at Plot No. E-47, Block-8, KDA, Scheme 24, Gulshan-e-Iqbal, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
