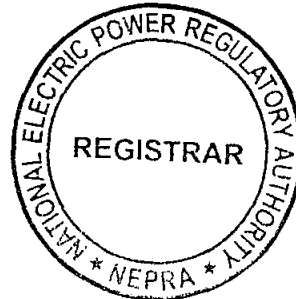



The Authority hereby grants Generation Licence to Mr. Qamar Alam for 29.975 KW photovoltaic solar based distributed generation facility, having consumer reference number LA913754, located at Plot No. E-143, Block-7, Gulshan-e-Iqbal, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
