The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to \*Master Sweetner having consumer Reference Number BH 001550 located at Plot No.E-115 to E-118 Bin Qasim North, West Industrial Zone Port Qasim, Karachi. This Licence is being issued in lieu of the earlier Licence dated July 30, 2021 to incorporate the enhancement in the capacity from 97.020 KW to 815.890 KW. However its term of seven (07) years will remain the same and expire on 29th day of July 2028.

- 2. The beneficiary shall abide by the provisions under the A&RE Regulations, as amended from time to time.
