The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to **\*Master Agro** having consumer **Reference Number BBB-BH001209** located at Plot No.C-12, Bin Qasim Karachi. This Licence is being issued in lieu of the earlier Licence dated July 30, 2021 to incorporate the enhancement in the capacity from 196.00 KW to 999.790 KW. 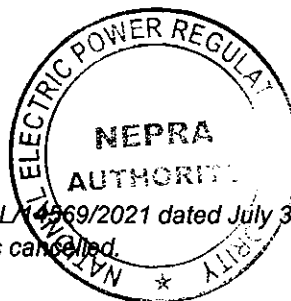
