The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to ***Zulekha Bai VM Gany Rangoon Wala Trust** having consumer **Reference Number BL 005697** located at Plot No. C/78, Dhoraji, CHS. This Concurrence is being issued in lieu of the earlier Concurrence dated August 23, 2023 to incorporate the enhancement in the capacity from 34.100 KW to 94.355 KW. However its term of seven (07) years will remain the same and expire on 22nd day of August 2030.

2. The beneficiary shall abide by the provisions under the A&RE Regulations, as amended from time to time.
