The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to \*Sumair Iqbal Pak Traders and Huller having consumer Reference Number BL 005906 located at F-14 Sector 50-C, Korangi. This Concurrence is being issued in lieu of the earlier Concurrence dated August 15, 2024 to incorporate the enhancement in the capacity from 33.200 KW to 193.850 KW. However its term of seven (07) years will remain the same and expire on 14th day of August 2031.
