The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to \*Chiniot Anjuman Islamia having consumer **Reference Number AL 885172** located at Plot No.St-13/2-2A, Block-7, Gulshan-e-Iqbal. This Licence is being issued in lieu of the earlier Licence dated February 03, 2023 to incorporate the enhancement in the capacity from 60.400 KW to 86.950 KW. However its term of seven (07) years will remain the same and expire on 02<sup>nd</sup> day of February 2030.

2. The beneficiary shall abide by the provisions under the A&RE Regulations, as amended from time to time.
