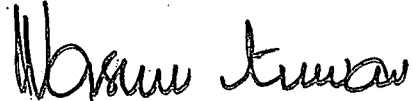

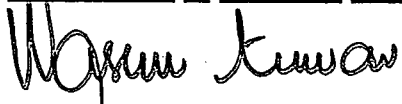
The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to ***Ahmed Food Ind.** having consumer **Reference Number BH 000675** located at Plot No. D-112, Site Karachi. This Licence is being issued in lieu of the earlier Licence dated October 01, 2021 to incorporate the enhancement in the capacity from 149.580 KW to 455.220 KW. However its term of seven (07) years will remain the same and expire on 30th day of September 2028.
