The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to \*Masood Tariq Baghpati having consumer Reference Number LA 138436 located at Plot No. C/49, KDA Scheme #01, Karachi. This Licence is being issued in lieu of the earlier Licence dated March 09, 2020 to incorporate the enhancement in the capacity from 24.00 KW to 74.100 KW. However its term of seven (07) years will remain the same and expire on 09<sup>th</sup> day of March 2027.
