The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to \*Sky Power (Pvt.) Ltd. C/o Mian Sultan Mahmood having consumer Reference Number 24 11531 9996113 U located at Plot No.4536, Race Course Road, Moza Halloki Station. This Licence is being issued in lieu of the earlier Licence dated January 13, 2020 to incorporate the enhancement in the capacity from 249.70 KW to 994.89 KW. However its term of seven (07) years will remain the same and expire on 12th day of January 2027.
