The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to \*Aleem Ahmad having consumer Reference Number 24 11741 9201002 U located at Oasis Golf & Aqua Resort Pvt. Ltd. Village Nathey Khalas, Lahore. This Licence is being issued in lieu of the earlier Licence dated September 04, 2020 to incorporate the enhancement in the capacity from 600.75 KW to 999.790 KW. However its term of seven (07) years will remain the same and expire on 03th day of September 2027.
