The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to \* **Rao Saad Ajmal Khan** having consumer **Reference Number 24 11455 2212902 R** located at Nayara Cold Storage Jalal Kot Depalpur. This Concurrence is being issued in lieu of the earlier Licence dated April 01, 2024 to incorporate the enhancement in the capacity from 120.06 KW to 179.715 KW. However its terms of seven (07) years will remain the same and expire on 31<sup>st</sup> day of March 2031.


2. The beneficiary shall abide by the provisions under the A&RE Regulations, as amended from time to time.
