The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to ***Zaffar Javeid Bhatti** having consumer **Reference Number 24 11563 9034109 U** located at Badian Road, Village Hear Lahore. This Licence is being issued in lieu of the earlier Licence dated December 17, 2021 to incorporate the enhancement in the capacity from 250.560 KW to 751.200 KW. However its term of seven (07) years will remain the same and expire on 16th day of December 2028.

3. The technical parameters of the Net Metering arrangements are as under:-

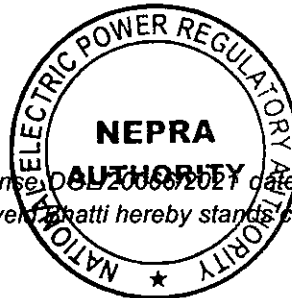
