The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to **\*Sharif Oxygen (Pvt.) Ltd.** having consumer **Reference Number 24 11121 2401600 U** located at G.T Road Ferozewala, Lahore, Askari Bank Ltd. This Concurrence is being issued in lieu of the earlier Concurrence dated August 28, 2024 to incorporate the enhancement in the capacity from 203.000 KW to 998.600 KW.
