The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to **\*Taj Flour & General Mills C/o Bassam Zubair** having consumer **Reference Number 24 11225 1004104 U** located at Imran Rice Sheller Raiwind Road, Manga Mandi. This Concurrence is being issued in lieu of the earlier Concurrence dated November 11, 2024 to incorporate the enhancement in the capacity from 320.760 KW to 650.570 KW. However its term of seven (07) years will remain the same and expire on 10<sup>th</sup> day of November 2031.
