The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to ***Mukaram Latif** having consumer **Reference Number 24 11614 0005701 U** located at Al-Raheem CNG Services, 3-KM Gujranwala Road, Kot Ranjeet, Sheikhpura. This Licence is being issued in lieu of the earlier Licence dated September 07, 2020 to incorporate the enhancement in the capacity from 11.200 KW to 82.490 KW. However its term of seven (07) years will remain the same and expire on 06th day of September 2027.
