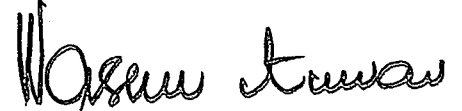

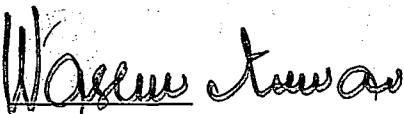
The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to ***Abdul Haq** having consumer **Reference Number 24 11612 0009902 R** located at Qila Amir Singh P/o Manoo Pur Tehsil & District Sheikhupura. This Concurrence is being issued in lieu of the earlier Concurrence dated November 14, 2024 to incorporate the enhancement in the capacity from 147.900 KW to 248.145 KW. However its term of seven (07) years will remain the same and expire on 13th day of November 2031.
