

Ltd. C/o Shahzad Farooq** having consumer **Reference Number 24 11162 9029725 U** located at Tayyaba Ind. Zone Bhatianawala 19-KM SKP Road. This Concurrence is being issued in lieu of the earlier Concurrence dated July 17, 2025 to incorporate the enhancement in the capacity from 595.530 KW to 999.775 KW. However its term of seven (07) years will remain the same and expire on 16th day of July 2032.
