
The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to ***Umair Ali Khalid** having consumer **Reference Number 24 11456 2314902 U** located at Cold Storage Chak Fazal Shah Haveli Rural Depalpur. This Licence is being issued in lieu of the earlier Licence dated June 29, 2022 to incorporate the enhancement in the capacity from 400.50 KW to 500.625 KW. However its term of seven (07) years will remain the same and expire on 28th day of June 2028.

2. The beneficiary shall abide by the provisions under the A&RE Regulations, as amended from time to time.
