

This Concurrence is being issued in lieu of the earlier Concurrence dated January 07, 2025 to incorporate the enhancement in the capacity from 139.755 KW to 249.260 KW. However its term of seven (07) years will remain the same and expire on 06<sup>th</sup> day of January 2032.
