The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to *Hamid Mehmood Raza having consumer <u>Reference Number 27 15641 0006002 U</u> located at Marriage Hall Chak No.166-P, Sadiqabad. This Licence is being issued in lieu of the earlier Licence dated July 02, 2021 to incorporate the enhancement in the capacity from 33.170 KW to 49.550 KW. However its term of seven (07) years will remain the same and expire on 01st day of July 2028.
