The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to *Jameel Qaiser having consumer Reference Number 27 15934 2350801 R located at Mahar Zari Cold Storage 127/15L, Bumbay Wala, M. Channu. This Licence is being issued in lieu of the earlier Licence dated June 27, 2022 to incorporate the enhancement in the capacity from 162.000 KW to 352.270 KW. However its term of seven (07) years will remain the same and expire on 26th day of June 2029.
