The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to ***Pak Madina Cold Storage C/o Muhammad Mushtaq** having consumer **Reference Number 27 15915 2696902 U** located at Chak No.136-10/R, Jahanian. This Concurrence is being issued in lieu of the earlier Concurrence dated June 14, 2024 to incorporate the enhancement in the capacity from 78.975 KW to 315.900 KW. However its term of seven (07) years will remain the same and expire on 13th day of June 2031.
