The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to \*Abid Hussain having consumer Reference Number 27 15531 1092204 U located at Abid Rice Mills Chak No. 155/EB, Arifwala. This Concurrence is being issued in lieu of the earlier Concurrence dated July 12, 2024 to incorporate the enhancement in the capacity from 248.400 KW to 498.960 KW. However its term of seven (07) years will remain the same and expire on 11th day of July 2031.
