The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to *Ch. Abdul Majeed having consumer **Reference Number 27 15521 0925403 R** located at Al-Farid Rice Mill Pull Rakh Pak Pattan. This Concurrence is being issued in lieu of the earlier Concurrence dated October 08, 2024 to incorporate the enhancement in the capacity from 100.430 KW to 159.720 KW.
