This Concurrence is being issued in lieu of the earlier Concurrence dated October 10, 2024 to incorporate the enhancement in the capacity from 139.780 KW to 240.210 KW. 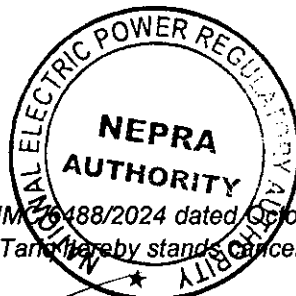
