The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to ***Rizwan Bashir** having consumer **Reference Number 27 15533 0064108 U** located at Allahabad Food Industry Chak No.75 EB, Qaboola Road, Arif Wala. This Concurrence is being issued in lieu of the earlier Concurrence dated July 13, 2023 to incorporate the enhancement in the capacity from 359.600 KW to 499.60 KW.
