The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to ***Mr. Ghulam Kibriya** having consumer Reference Number 27 15618 2145409 R located at Waqas Fahad Flour & General Mills, Klp Road, Rahim Yar Khan. This Licence is being issued in lieu of the earlier Licence dated October 21, 2020 to incorporate the enhancement in the capacity from 125.280 KW to 497.835 KW.
