The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Licence to **\*Mr. Muhammad Riaz** having consumer **Reference Number 27 15545 0475004 R** located at Prop. Baber Ice Factory Chak No. 171/9-L Burewala Road, Chichawatni. This Licence is being issued in lieu of the earlier Licence dated January 20, 2022 to incorporate the enhancement in the capacity from 90.95 KW to 159.95 KW. However its term of seven (07) years will remain the same and expire on 19<sup>th</sup> day of January, 2029.
