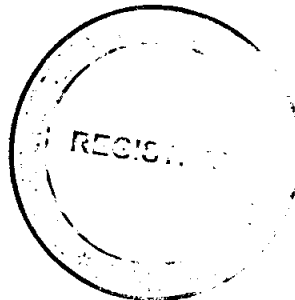



The Authority hereby grants Generation Licence to Mr. Akhtar Sultan Khan, for 13.11 KW photovoltaic solar based distributed generation facility, having consumer reference number 02-26216-0251140, located at House # 109, Street # 7, Sector F/4, Phase-6, Hayatabad, Peshawar under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. This Licence is valid up to 25<sup>th</sup> day of Aug 2027.
