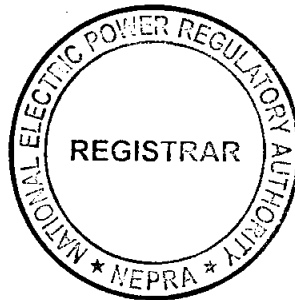



The Authority hereby grants Generation Licence to Mr. Arbab Faisal Habib, for 5.28 KW photovoltaic solar based distributed generation facility, having consumer reference number 06 26216 0281500 U, located at F-7-105, Phase 7, Hayatabad, Peshawar under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
