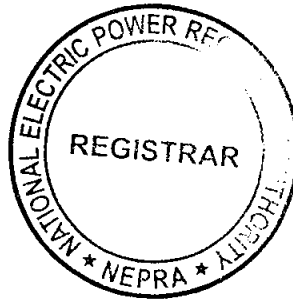



The Authority hereby grants Generation Licence to Mr. Wali Mast, for 15.13 KW photovoltaic solar based distributed generation facility, having consumer reference number 30-26112-0035984 U, located at Peshawar Garden, G.T Road, Peshawar under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 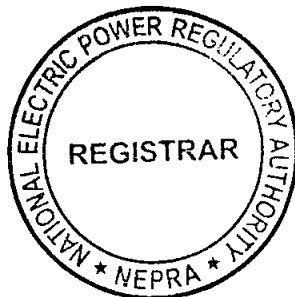
