

The Authority hereby grants Generation Licence to Mst. Rakshanda Sharif, for 22.50 KW photovoltaic solar based distributed generation facility, having consumer reference number 06 26214 0073525 U, located at House # 129, Sector G-3, Phase 2, Hayatabad, Peshawar under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. This Licence is valid up to 12<sup>th</sup> day of Oct, 2028.

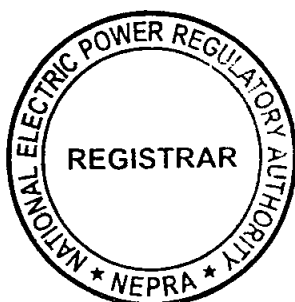
