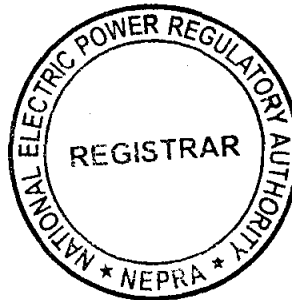



The Authority hereby grants Generation Licence to Mr. Shaukat Hayat, for 10.165 KW photovoltaic solar based distributed generation facility, having consumer reference number 06 26214 0081380 U, located at Plot # 115, Sector H-2, Phase 2, Hayatabad, Peshawar under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
