The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to ***Sirtaj Flour Mills C/o Farooq Elahi** having consumer **Reference Number 30 26424 0000200 U** located at Sirtaj Flour Mills Havelian. This Concurrence is being issued in lieu of the earlier Concurrence dated December 12, 2024 to incorporate the enhancement in the capacity from 130.455 KW to 245.745 KW. However its term of seven (07) years will remain the same and expire on 11th day of December 2031.
