The Authority under Regulation-4 of NEPRA (Alternative & Renewable Energy) Distributed Generation and Net metering Regulations, 2015 (the "A&RE Regulations") grants Distributed Generation Concurrence to **\*Mercy Pak C/o Ijaz Ali Shah** having consumer **Reference Number 30 26115 0000802 U** located at Nasir Pur Peshawar. This Concurrence is being issued in lieu of the earlier Concurrence dated February 17, 2025 to incorporate the reduction in the capacity from 60.255 KW to 39.780 KW. However its term of seven (07) years will remain the same and expire on 16<sup>th</sup> day of February 2032.

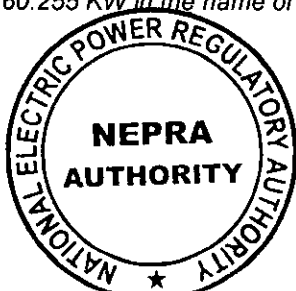
